## **Crime Prevention Tips & Safety Awareness:**

### **Burglaries of Motor Vehicle:**

- Ensure you always secure your vehicle, closing all windows and locking all doors.
- Tell your contractor(s) to do the same.
- Do not leave valuables in plain sight in your vehicles.
- Handguns should not be left in the vehicle overnight, unless secured in a vehicle safe.
- Install Apple Air tags or some other tracking device.
- Secure your key fobs in a RFID blocking device that prevents signals from transmitting. A plain metal gift box will suffice!

### **Homes:**

- Install a security system and surveillance cameras with monitoring capabilities, especially for vacant and for-sale homes.
- Ensure your alarm company has Pct. 5 as the listed agency to contact when an alarm goes off at your residence.
- If your residence is for sale or rent ensure that your realtor uses a digital lockbox.
- If you see someone or something suspicious, immediately contact Pct. 5 Dispatch at 281-463-6666.

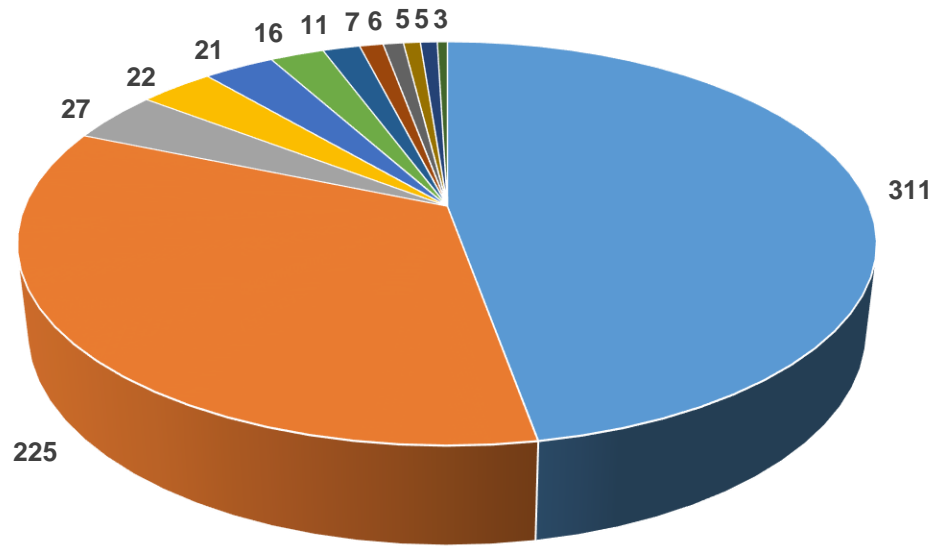
### **Construction Sites:**

- Secure your site with fencing and a privacy screen.
- Install surveillance cameras on the property.
- Avoid having construction materials dropped off on the weekend.
- Home appliances should be the last items installed in a new home.
- If your residence is under construction or renovation always use a digital lockbox for additional security.
- At or near the end of construction, contact Pct 5 to place a special watch on the site.

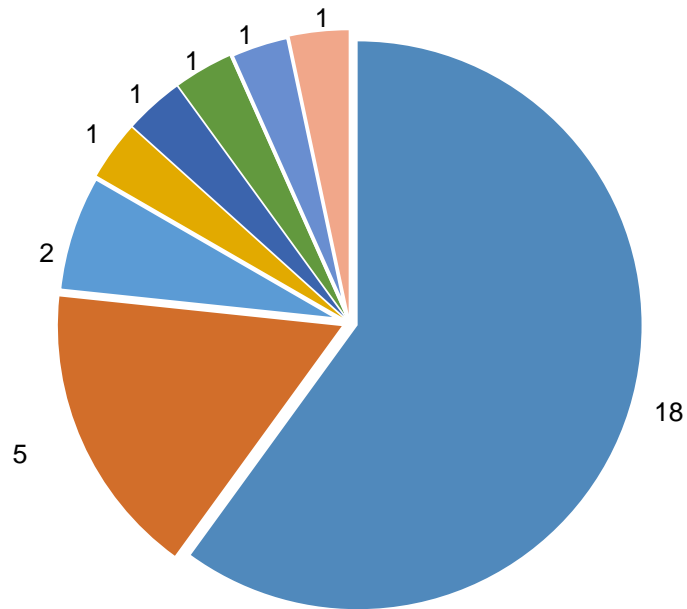
